All applications will be reviewed for approval by the National Association of REALTORS® at the mid-year meeting or NAR's Annual Conference. Upon approval, REALTOR® Emeritus members will receive a congratulatory letter, certificate, and 40-year REALTOR® Emeritus lapel pin. REALTOR® Emeritus members receive a waiver of all membership dues and are exempt from the Code of Ethics Training Requirement. Please note that the dues waiver does not take effect until the dues year immediately following the Board of Directors' approval.
